- G. **XX:** Identified the conditions for an apartment: close to son-in-law's work since they only have one car plus must be in a certain geographic area. **XX:** Noted that they completely understood what SR was saying regarding the situation.
- H. XX: Left the Zoom Supplementary Board meeting.
